1. **Call to Order; Roll Call**-Call to Order 9:32a.m. Committee Chair Charles Lindenblatt and committee member Bob Abrahams were present; a quorum was present.
2. **Approval of Minutes of 04/07/11 meeting – Action May Be Required. (2 min.)**-Chair Charles Lindenblatt moved, and Bob Abrahams seconded, approval of the minutes; approval came on a 1-0-1 vote.
3. **Public Comment Period**-There was no public comment.
4. **Chairman’s Report**-The Chair decided not to read the committee’s mission statement.
5. **Continuation of initial review of the complaint filed March 28, 2011 by Stakeholder James O’Sullivan regarding Chair Jeff Jacobberger.** Consideration of this item will only include the following:
  - a. Determination of whether or not the complaint that was filed is in compliance with Article V., Section 10 in accordance with MCWCC grievance procedure prescribed by Article V., Section 10b. **Action May Be Required.**

After discussion of the advice provided by the City Attorney, committee member Bob Abrahams moved, and Charles Lindenblatt seconded, a motion to not hear the complaint regarding conflict of interest violations, on the advice of the City Attorney; approval came on a vote of 2-0.

- b. If the complaint is found to be compliance, Committee will determine the affected parties, and approve service, in compliance with MCWCC grievance procedure prescribed by Article V., Section 10c. (i.-iii.) . **Action May Be Required.**
6. **Discussion of status of MCWCC Bylaws Amendment process to become in compliance with the Board of Neighborhood Commissioners’ (BONC’s) citywide Bylaw Table of Contents.**

The Chair announced that the Committee and Board are still awaiting DONE’s approval of our amended Bylaws.
