- 2. **September 2011 Congress of Neighbors:** (10min)

- a. **MOTION TO CONTRIBUTE UNSPENT 2010-11 FUNDS TO CONGRESS OF NEIGHBORHOODS.**
- b. The City Charter requires the City to hold a Congress of Neighborhoods. Due to budget issues, DONE and NC activists organizing the Congress are requesting that neighborhood councils contribute to offset costs of the Congress, which will be held at City Hall in September 2011. A request was made on Saturday, June 11.
- c. The last day to make a P-Card purchase using FY2010-11 funds is June 15, 2011.

- 3. **California Redistricting** (25 min)

- a. The California Redistricting Commission released draft maps for Assembly, State Senate and Congressional District on Friday, June 10.

- b. The Commission will hold a public hearing in Culver City on June 16, 2011; the commission will possibly issue final maps in July 2011, which makes it uncertain whether deferring the issue to July will deprive Mid City West CC of the ability to influence the district lines.
  - c. On June 11, 2011, Mid City West received a request that it consider taking a position on the proposed district boundaries, which are on line at [wedrawthelines.ca.gov](http://wedrawthelines.ca.gov).
