PROPOSED PROJECT: A proposed ordinance amending Sections 12.03, 12.21, and 12.21.1 of the Los Angeles Municipal Code (LAMC) to expand bicycle parking requirements to cover multi-family residential developments, define acceptable locations for bicycle parking, require that both short-term and long-term bicycle parking be provided, improve design standards, and increase the levels of bicycle parking required under the current code for new developments, buildings undergoing major remodels, and buildings undergoing a change of use.

Discussion about TPS committee reconsidering the Bicycle Parking Ordinance. As it stands currently, there is no recommendation from MCWCC on this proposal as the Motions from both PLUC and TPS were defeated. **(May require action) (See Attachment)**
